PRIVATE EVENT INFORMATION 2022

SOCIAL HALL RENTAL ONLY

The historic Social Hall was built in 1870 as the community social gathering place for the town of Comfort. Adorned with high ceilings and fresh white paint, the historic Social Hall has 9 farm tables and seating for 74 guests. This climate-controlled space is perfect for dinner parties, cocktail gatherings, meetings, and small receptions and includes two restrooms.

Site fee of \$750 (weekends) and \$600 (week nights) applies + may be required to book rooms/cabins. Our weekends have a two-night minimum for booking of cabins and suites.

SOCIAL HALL WITH COURTYARD + CYPRESS CREEK PROPERTY BUYOUT

Camp Comfort offers a full buyout of all 4 suites, 5 cabins, our Camp Bambi Airstream for a total of 30 overnight guests based on availability. Room fees are in addition to site/venue fee and rooms may be placed on hold for guests to book separately. Guests may have use of the entire property for their group and exclusive access to common spaces to host up to 250 people for one event. There is a two-night lodging minimum for all property buyouts.

Venue site fee of \$3,500 applies + must book all rooms/cabins



PRIVATE EVENT POLICIES 2022

CATERING, COORDINATION, RENTALS & DÉCOR

Camp Comfort offers an exclusive list of catering and vendor options from which to choose. Outside caterers may be used with prior approval from management. We highly recommend you hire a qualified professional; however, you are welcome to provide your own catering, coordination, rentals & décor. We do not have cooking facilities onsite.

MUSIC & ENTERTAINMENT

Loud music on the property must end by 10 p.m. out of consideration for our neighbors. Music must be kept at a considerate volume of no more than 75 decibels.

ALCOHOL & SECURITY

All alcohol must be served by a TABC certified bartender. Security is required for all events where alcohol is served to guests not staying on the Camp Comfort property.

ROOM GROUP BOOKINGS

Event bookings are handled separately from room bookings and all site fees are in addition to room bookings. Most group bookings require a two-night minimum stay. Some exceptions are allowed and must be approved by management. Rates are subject to change until a deposit has been made.

EVENT PAYMENT POLICY

To secure the date of the event, a non-refundable \$500 deposit and signed contract are required. Remittance of the non-refundable deposit will hold the date and be applied to the final balance.

The balance is due 30 days prior to the event. Final guest count is required 10 days prior to the event.

Rates are subject to change until deposit has been made and contract signed.

CANCELLATION POLICY

Camp Comfort must be notified in writing prior to the event with confirmation of receipt. The initial non-refundable \$500 deposit will be forfeited. Room cancellation fees are in addition to event cancellation fees.

INDEMNIFICATION

The client agrees to indemnify Camp Comfort and incurs all responsibility for any and all actions, losses, damages, claims or liability resulting from your event. Camp Comfort recommends the purchase of special event liability insurance.
